## What is the purpose of this update?

This document tells you how the Simplicity KiwiSaver Growth Fund (Growth Fund) has performed and what fees were charged. The document will help you to compare the fund with other funds. Simplicity NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

The Growth Fund provides investors with a limited exposure to income assets, but most of its investments are in growth assets. As a result, the return from the Fund is likely to be higher over the longer term (10 years or more) than the Balanced or Conservative Funds, but the value of its investments is likely to fluctuate more than the Balanced or Conservative Funds.

## What are the risks of investing?

### Risk indicator



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

## How has the fund performed?

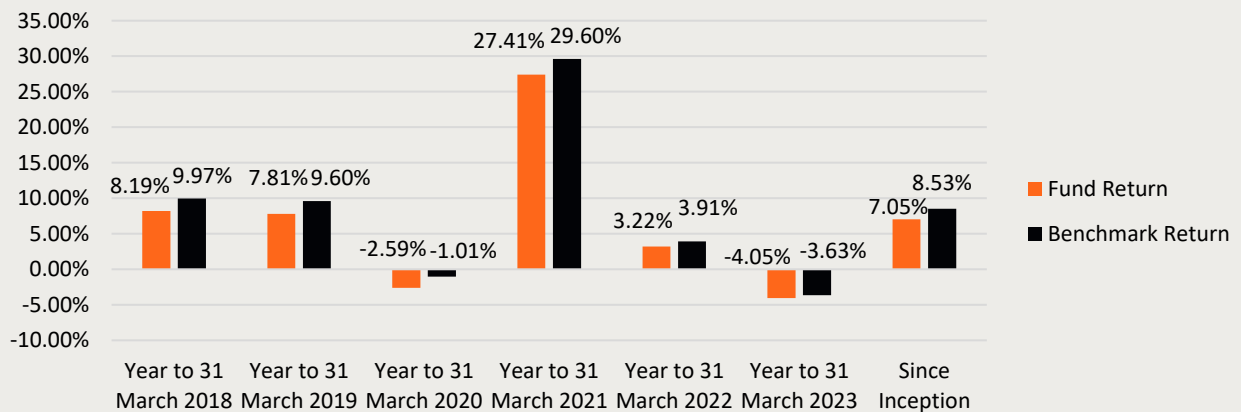

## Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

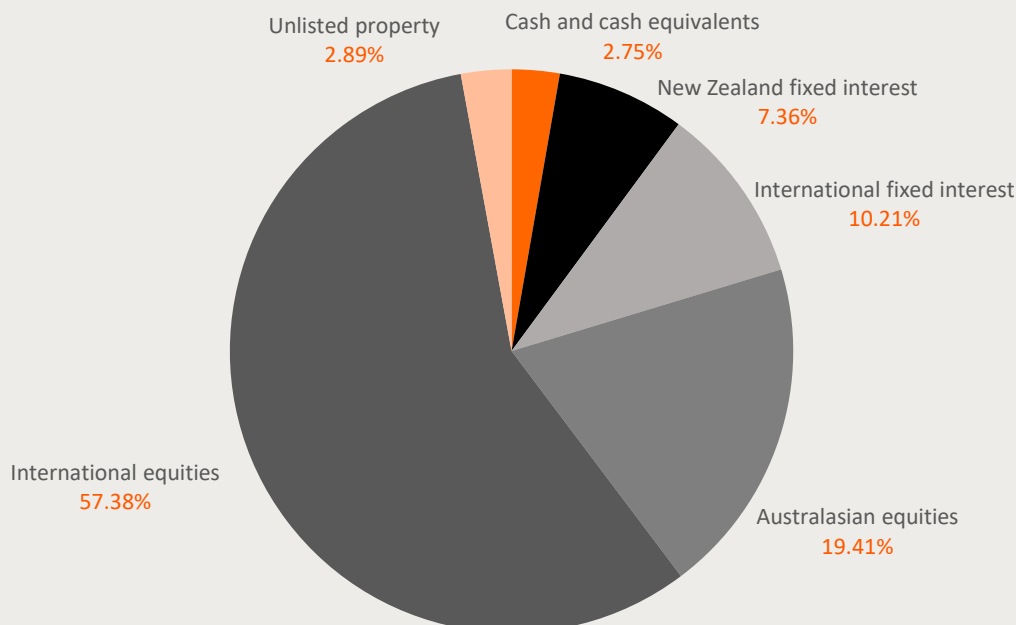
Kenny had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Kenny received a return after fund charges were deducted of \$1,667 (that is 16.67% of their initial \$10,000). This gives Kenny a total return after tax of \$1,515 for the period.

The top ten investments make up 19.73% of the fund. The fund's exposure to assets denominated in foreign currencies was 69%, of which 71% was hedged. This means the fund's unhedged foreign currency exposure was 20% of the net asset value of the fund.<sup>3</sup>

## Notes

1. Effective from 1 February 2024 the Manager's basic fee is reduced to 0.25%. The Manager's basic fee was reduced by 0.01% to 0.29% with effect from 1 April 2023. Other management and administration charges include a 0.01% estimated fee which covers administration costs incurred by the Vanguard underlying funds. This estimate is based on actual annual costs reported by Vanguard in its annual report dated 30 June 2022 with additional details provided by Vanguard. Effective on 28 April 2023 management of international equities and bonds was transferred from Vanguard to DWS International GmbH and the Other management and administration charges were removed.
2. Our target equities exposures are 16.5% to New Zealand equities and 59% to International equities (which includes approximately 2% Australian equities). We have no target for listed property. Exposures to real estate investment trusts are included in equities.
3. Our hedging policy is set using the market average hedging ratio of providers that make up at least 80% of KiwiSaver industry funds under management, resulting in our international fixed interest and equity investments being 100% and 65% hedged into New Zealand dollars respectively. The hedging policy for equities is reviewed six monthly and adjusted from time to time to follow the market reference within a range of 55% - 75%. Hedging instruments are not listed in the top 10 investments.
