## What is the purpose of this update?



## Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Kenny had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Kenny received a return after fund charges were deducted of \$356 (that is 3.56% of their initial \$10,000). This gives Kenny a total return after tax of \$247 for the period.
