What is the purpose of this update?

This document tells you how the Simplicity Balanced Investment Fund (Balanced Fund) has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

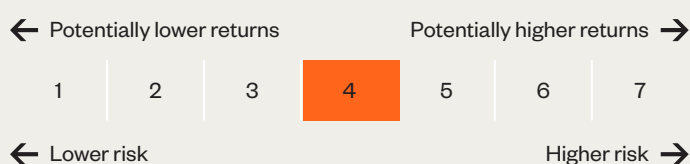
The Balanced Fund provides investors with an exposure to a mix of growth and income assets. As a result, the return from the Fund is likely to be lower over the longer term (10 years or more) than the Growth Fund, but the value of its investments is likely to fluctuate more than the Conservative Fund.

What are the risks of investing?

Risk indicator



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the fund performed?

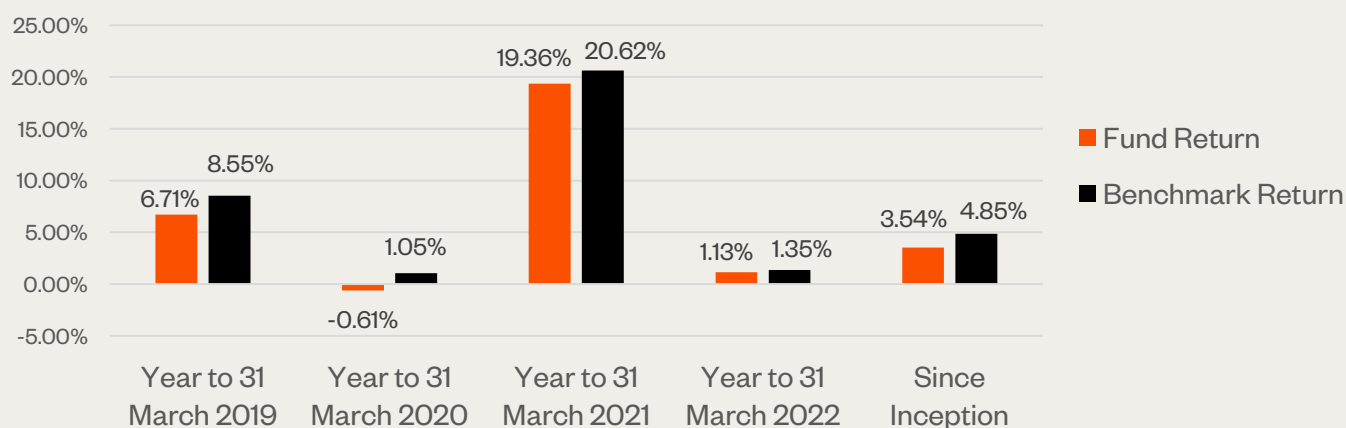

Small differences in fees and charges can have a big impact on your investment over the long term.

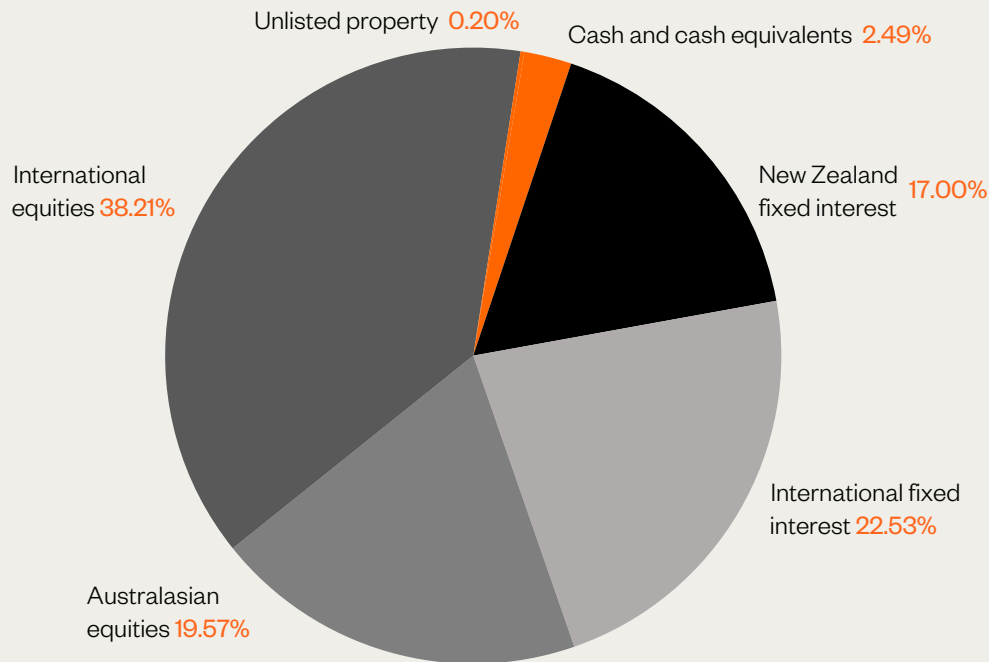
Kate had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year Kate incurred a loss after fund charges were deducted of \$1,304 (that is -13.04% of her initial \$10,000). Kate also paid \$5 in other charges. This gives Kate a total loss after tax of \$1,250 for the period.

The top ten investments make up 74.16% of the fund. The fund's exposure to assets denominated in foreign currencies was 65.15%, of which 76.53% was hedged. This means the fund's unhedged foreign currency exposure was 15.29% of the net asset value of the fund.³

Notes

1. Other management and administration charges include a 0.01% estimated fee which covers administration costs incurred by the Vanguard underlying funds. This estimate is based on actual annual costs reported by Vanguard in its most recent annual report dated 30 June 2022 with additional details provided by Vanguard, and anticipated investment levels in the underlying funds in accordance with the Scheme's SIPO.
2. In December 2021 the monthly administration fee was removed and will no longer be charged.
3. Our hedging policy is set using the average of the 12 main providers that we monitor, resulting in our international fixed interest and equity investments being 100% and 65% hedged into New Zealand dollars respectively. The hedging policy for equities is monitored quarterly and adjusted from time to time to follow the average within a range 50% - 70%.
