What is the purpose of this update?

This document tells you how the Simplicity KiwiSaver Growth Fund (Growth Fund) has performed and what fees were charged. The document will help you to compare the fund with other funds. Simplicity NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

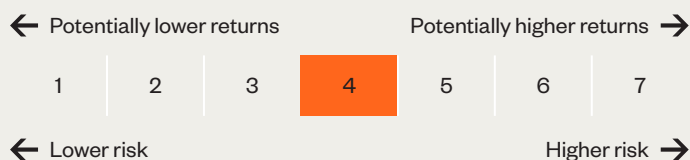
The Growth Fund provides investors with a limited exposure to income assets, but most of its investments are in growth assets. As a result, the return from the Fund is likely to be higher over the longer term (10 years or more) than the Balanced or Conservative Funds, but the value of its investments is likely to fluctuate more than the Balanced or Conservative Funds.

What are the risks of investing?

Risk indicator for the Growth Fund¹:

Risk indicator



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

As the fund has not been in existence for five years, the risk indicator is based on five year information including actual performance figures from 1 September 2016, and market returns data for the period prior to that date. As a result of this, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.

Example of how this applies to an investor

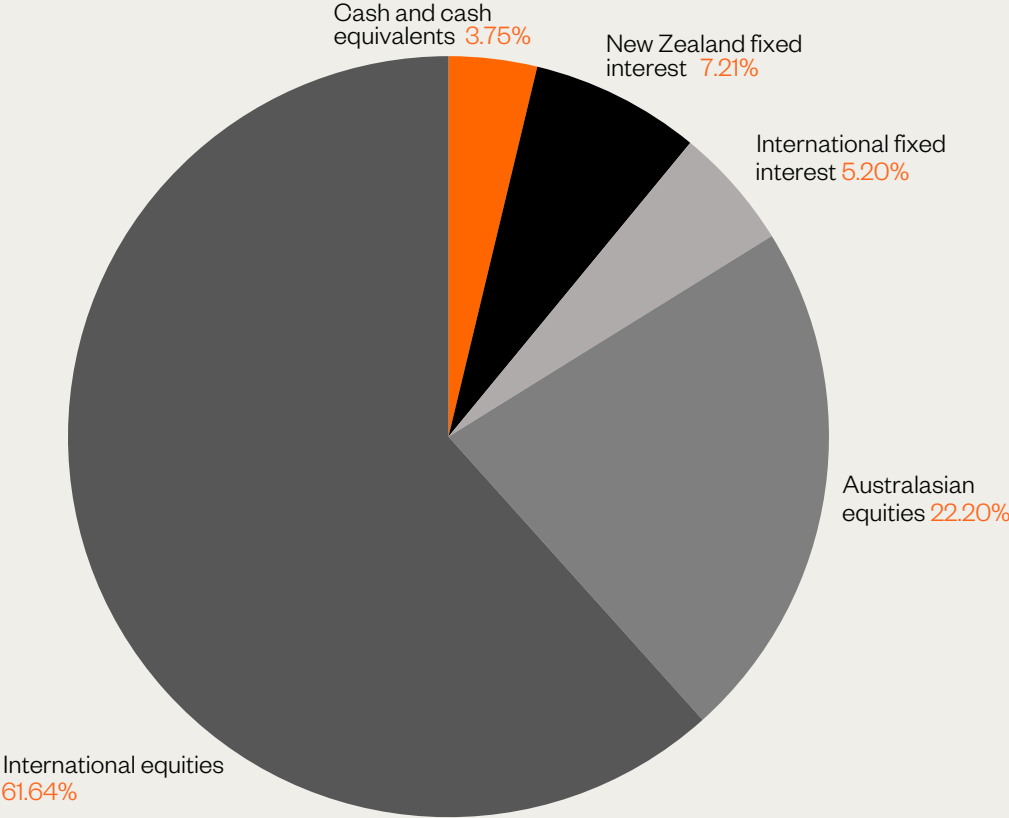
Small differences in fees and charges can have a big impact on your investment over the long term.

Ben had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of \$1,165 (that is 11.65% of his initial \$10,000). Ben also paid \$30 in other charges. This gives Ben a total return after tax of \$1,135 for the period.

To calculate the risk indicator for the five-year period ending 30 September 2017, market index returns have been used up to 31 August 2016 with actual fund returns used for the balance of the period.
