What is the purpose of this update?

This document tells you how the Simplicity Conservative Investment Fund (Conservative Fund) has performed and what fees were charged. The document will help you to compare the fund with other funds. Simplicity NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Conservative Fund provides investors with a limited exposure to growth assets, but most of its investments are in income assets. As a result, the return from the Fund is likely to be lower over the longer term (10 years or more) than the Balanced or Growth Funds, but the value of its investments are unlikely to fluctuate as much as the Balanced or Growth Funds.

What are the risks of investing?

Risk indicator



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the fund performed?

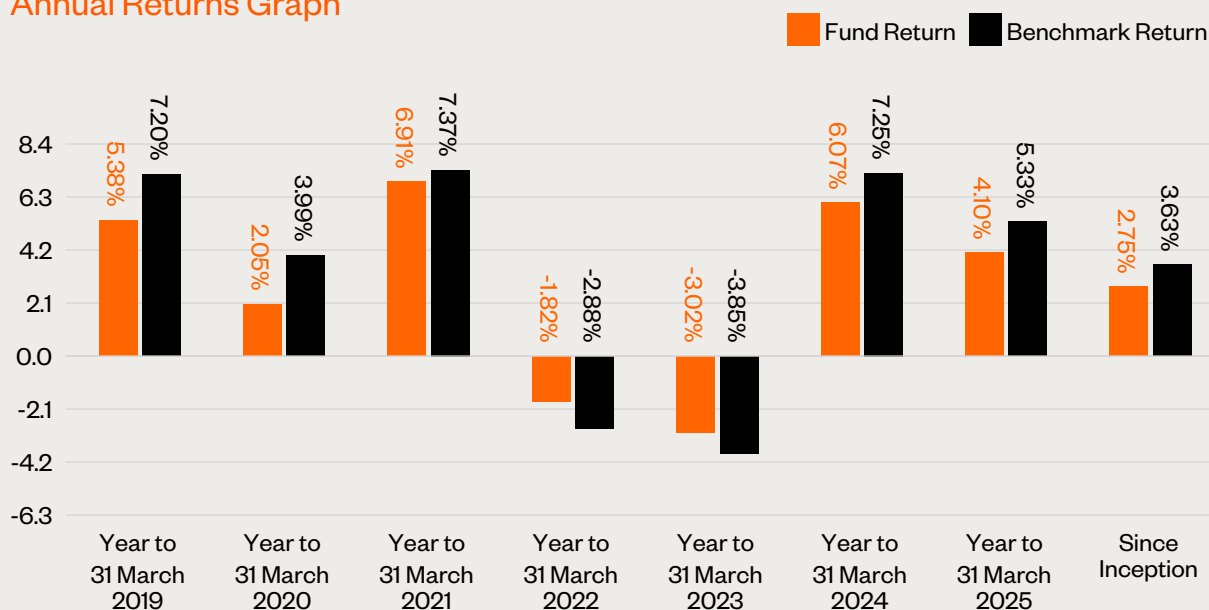

Small differences in fees and charges can have a big impact on your investment over the long term.

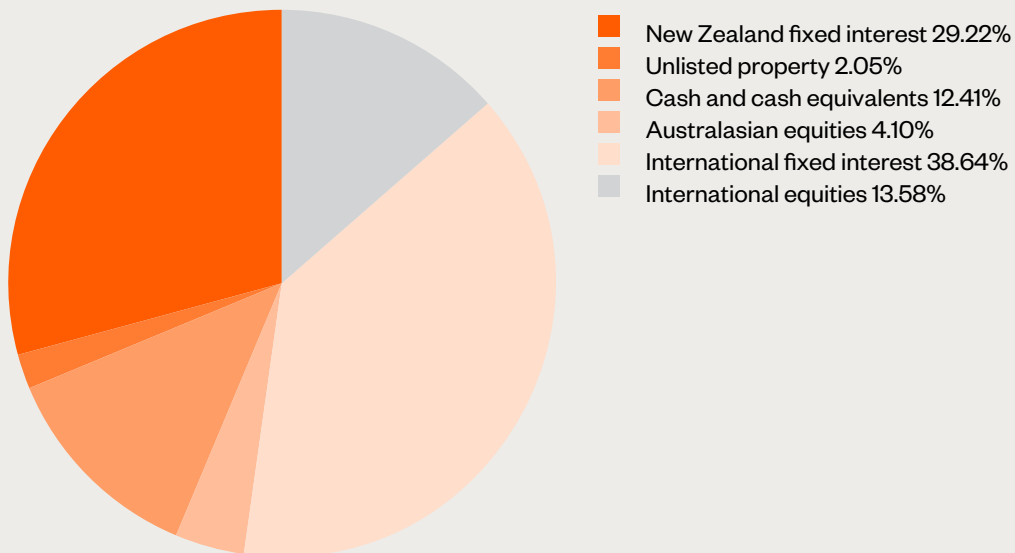
Artie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Artie received a return after fund charges were deducted of \$536 (that is 5.36% of their initial \$10,000). This gives Artie a total return after tax of \$410 for the period.

The top ten investments make up 17.45% of the fund. The fund's exposure to assets denominated in foreign currencies was 53%, of which 87% was hedged. This means the fund's unhedged foreign currency exposure was 7% of the net asset value of the fund.⁴

Notes

1. The fund's risk indicator has reduced from "4" in the previous fund update to "3" in this fund update. This change is primarily due to the period over which the risk indicator is calculated – the risk indicator in this fund update was calculated based on returns data for the 5 years from 1 April 2020 to 31 March 2025, which excludes a period of increased volatility in March 2020 which was driven by the COVID pandemic.
2. Effective from 1 February 2024 the Manager's basic fee was reduced to 0.25%.
3. Our target equities exposures are 3.5% to New Zealand equities and 14% to International equities (which includes approximately 1.75% Australian equities). We have no target for listed property. Exposures to real estate investment trusts are included in equities.
4. Our hedging policy is set using the market average hedging ratio of providers that make up at least 80% of KiwiSaver industry funds under management, resulting in our international fixed interest and equity investments being 100% and 50% hedged into New Zealand dollars respectively. The hedging policy for equities is reviewed six monthly and adjusted from time to time to follow the market reference within a range of 40% - 60%. Hedging instruments are not listed in the top 10 investments.
