What is the purpose of this update?

This document tells you how the Simplicity Hedged Global Share Fund (Hedged Global Share Fund) has performed and what fees were charged. The document will help you to compare the fund with other funds. Simplicity NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Hedged Global Share Fund invests in shares across developed markets, designed to generate a return similar to the performance of the Bloomberg DM ex NZ ESG Screened index (NZD hedged) and to be the hedged International shares component of a diversified investment portfolio.

What are the risks of investing?

Risk indicator for the Hedged Global Share Fund:¹

Risk indicator



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

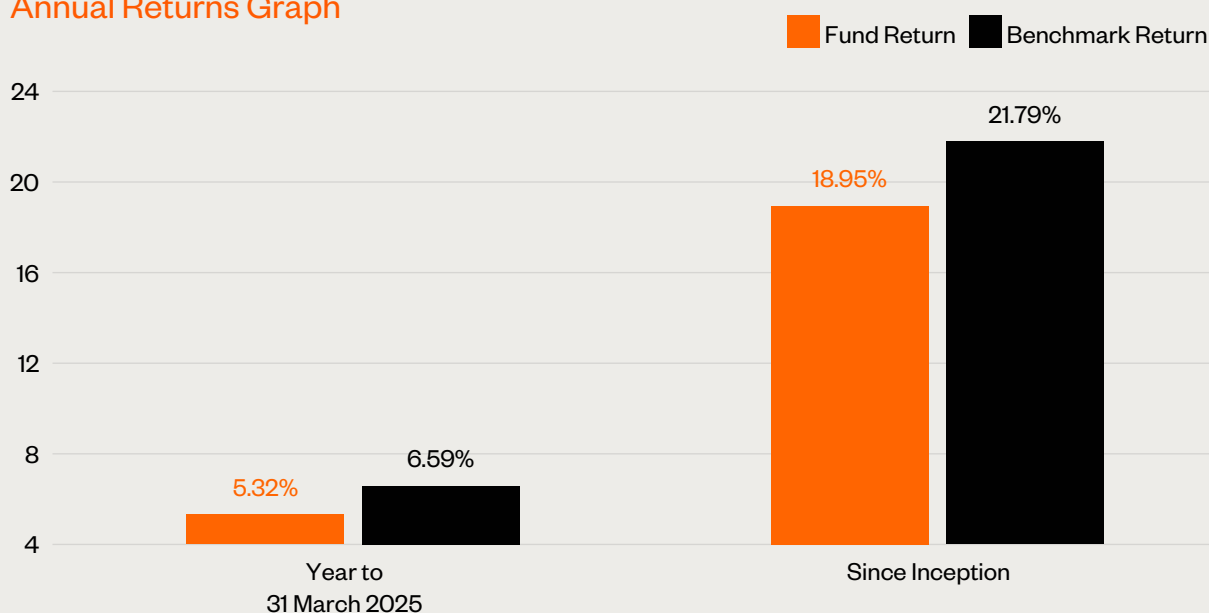

Small differences in fees and charges can have a big impact on your investment over the long term.

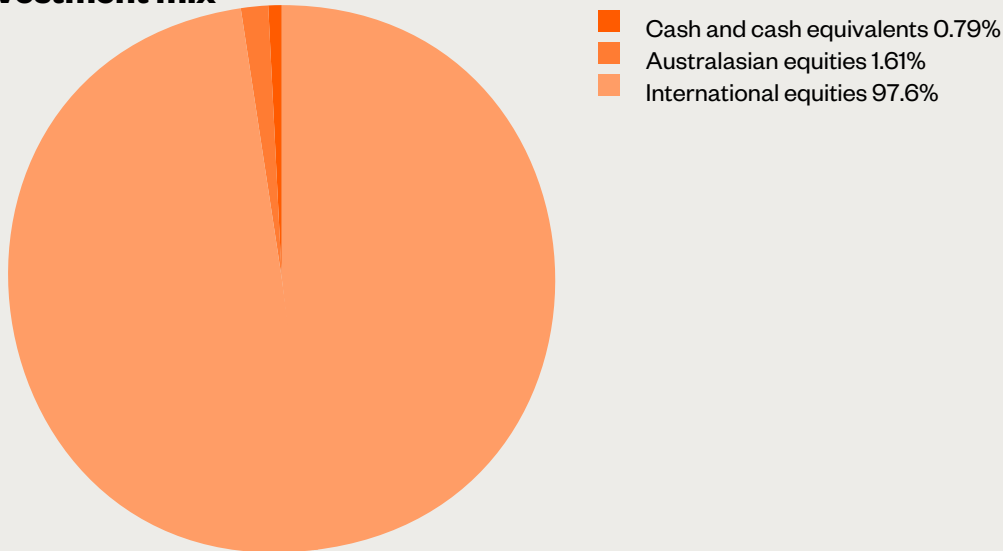
Artie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Artie received a return after fund charges were deducted of \$1,650 (that is 16.5% of their initial \$10,000). This gives Artie a total return after tax of \$1,493 for the period.

Notes

1. As the fund started on 28 April 2023, five-year actual returns for the fund are not available. To calculate the risk indicator for the five-year period ending 30 September 2025 market index returns have been used up to 28 April 2023 with actual fund returns used for the balance of the period. As a result of those market returns, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund.
2. We have no specific target for Australasian equities. Exposure to Australasian equities is included in International equities. We have no target for listed property. Exposures to real estate investment trusts are included in International equities.
