### What is the purpose of this update?

## Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Artie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Artie made a loss after fund charges were deducted of \$111 (that is -1.11% of their initial \$10,000). This gives Artie a total loss after tax of \$212 for the period.
