What is the purpose of this update?

This document tells you how the Simplicity NZ Share Fund (NZ Share Fund) has performed and what fees were charged. The document will help you to compare the fund with other funds. 
Small differences in fees and charges can have a big impact on your investment over the long term.

Artie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Artie made a return after fund charges were deducted of \$1,014 (that is 10.14% of their initial \$10,000). This gives Artie a total gain after tax of \$910 for the period.
