



#### What is the purpose of this update?

This document tells you how the Simplicity NZ Share Fund (NZ Share Fund) has performed and what fees were charged. The document will help you to compare the fund with other funds. Simplicity NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### Description of this fund

The NZ Share Fund invests in securities listed on the New Zealand stock exchange (NZX), designed to be the New Zealand share component of a diversified investment portfolio.


#### How has the fund performed?

Investors are not charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds).


# Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

Artie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Artie received a return after fund charges were deducted of \$666 (that is 6.66% of their initial \$10,000). This gives Artie a total return after tax of \$569 for the period.
