
Description of this fund

What are the risks of investing?


Small differences in fees and charges can have a big impact on your investment over the long term.

Artie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Artie made a return after fund charges were deducted of \$1,106 (that is 11.06% of their initial \$10,000). This gives Artie a total gain after tax of \$1,003 for the period.
